



MC1215 | Police Interaction Script

We have put together some helpful tips in dealing with police. As all interactions are unique these suggestions are to be used as a guide only and by no means are a guarantee of success.

Start video recording

1

Before we can proceed, I need to confirm your identity. I require your name, rank, badge number and station. If refuse to answer, ask 3 times.

If 1 answered, **go to 2**

If refusal to answer, **go to 1a**

1a

Do you deny that failure to identify is misconduct in public office? If refuse to answer, ask 3 times.

If refusal to answer, **go to 2**

2

Is it true that you are a public servant? If refuse to answer, ask 3 times.

If 2 answered, **go to 3**

If refusal to answer, **go to 5**

3

Are you standing under your oath of office of constable? If refuse to answer, ask 3 times.

If 3 answered, **go to 4**

If refusal to answer, **go to 3a**

3a

Do you deny that in order for a public servant, as you claim to be, to have the authority granted by the people, you must be able to establish that you act in strict adherence to the principles of universal morality which is why the oath of office of constable was created? If refuse to answer, ask 3 times.

If 3a answered, **go to 3**

If refusal to answer, **go to 5**

4

A constable must recite their oath upon request therefore I require you to recite your oath of office now in order to verify that you hold the authority granted by we the people. If refuse to answer, ask 3 times.

If 4 answered, **go to 6**

If refusal to answer, **go to 5**

5

Being that you are not a public servant standing in the authority granted by we the people to the office of constable represented in the oath, that means you are impersonating a constable which is a criminal offence that carries jail time. Do you deny that you are committing a serious criminal offence by refusing to establish whether you stand under the authority granted to the office of constable by the people. If refuse to answer, ask 3 times.

If refusal to answer, **go to 5a**

5a

Are you standing under maritime admiralty law of commerce with the intention to conduct commerce through the presumption of tacit agreement to the verbal contract you are reciting in order to generate a case number? If refuse to answer, ask 3 times.

If refusal to answer, **go to 5b**

5b

I require you to produce the source of authority upon which you rely. If refuse to answer, ask 3 times.

Regardless of answer, **read out caution card**

6

Constable [name] what is the purpose of your visit / why have you impeded my right to free travel?

Regardless of answer, **read out caution card**

7

I require you to call your superior. If refuse to answer, ask 3 times.

If the police threaten you with violence as a means of compliance to their demands

8

I am feeling alarmed and distressed because I'm in fear of my safety now that you are threatening me with violence if I do not comply with your unlawful demands. As my first duty under the law is to protect myself from loss or harm then I will be complying with your demands to break the law, under duress, which means that you are now solely responsible for making me break the law which is being recorded as evidence for your trial before a jury of the people.

I would like to remind you that you will be standing alone, without your costume and armour or the protection of the legal or legislative system, in your private and unlimited capacity for forcing me to break the law. Do you understand?

Repeat the process when superior arrives until then engage in further questioning only this time on the quality of their morals.

Who bares the greater burden of responsibility and moral culpability? The one giving the order or the one that follows and carries it out? If refuse to answer, ask 3 times.

9a

You have two choices:

1. Carry on as you are, and the karmic debt will haunt your soul for eternity;
2. Stand under the morality of the common law oath of office of constable you took that binds you to protect the people's sovereignty and you may be granted clemency when you stand before the very people you have been violating as a means to clear some of the karmic debt you've accrued for the transgressions you've committed against the very people you swore and oath to protect.
