

How to print

1. Print the pocket caution card for Article 61 and the relevant police conduct card for your state or territory.
2. Cut around the outside line.
3. Fold in half at the centre line.
4. If you're printing on paper, laminating is ideal to preserve the longevity. If laminating is not an option, you can print on a heavier card as often as needed.

MC1215 | **Pocket Caution Card**

I must caution you!
