## To All members of Judiciary,

Every living thing has the right to survive and thrive. This is a basic truth: if it weren't true, life itself wouldn't make sense. Actions that help others live better or longer, like offering food or shelter, are what's termed a right action. Actions that harm others or prevent them from meeting their basic needs, like depriving them of food or shelter, are deemed as wrongs. We all share this right equally, and respecting it keeps life in balance and harmony.

Freedom and self-responsibility are truths that have no place in today's so-called "legal system," which was designed to replace real law with a facade of formality, concealing its intent to control through deception and force. Over time, these natural principles, once widely recognised and practised, have been systematically erased from public consciousness; removed from education and everyday life; leaving most people unaware of the innate authority they carry. In their place, we've been conditioned to obey a system that mimics lawfulness yet stands in direct violation of the moral order written into the human heart. Yet, the truth is inextinguishable: the principles of genuine common law embodied in the Magna Carta still stand as a silent witness, and even governments, despite every effort to bury its meaning, commemorated its 800th anniversary in 2015, unintentionally reminding us of what still endures.

The authentic rule of law, upheld through the people and supreme law council of Trial by Jury, remains the sole mechanism for holding government agents (Crown representatives) accountable for unlawful actions. Under this system, no individual or entity is shielded from liability for breaching universal morality, as outlined by genuine common law.

Why wouldn't we embrace such a powerful shield for justice and sovereignty? Especially when even a brief look at the vast body of legislation accumulated over the past 800 years reveals how it has been misappropriated and weaponized: used to violate natural law, which remains easily recognisable through each individual's moral compass. Through this distortion, legislation has been used to manufacture an artificial divide that creates two classes: a self-appointed superior class that monopolises force to impose its will, over a subordinate class that never consented to such egregious violations of their inalienable rights - yet continues to be harvested and plundered for the wealth they produce.

Opportunities to undo centuries of injustice have been rare. For over 800 years, those who seized the levers of power have steadily undermined the protections affirmed in Magna Carta 1215, co-opting legislation to serve their appetites for centralising and concentrating power. This distortion has been sustained not by accident, but through a calculated effort to engineer the abandonment of each individual's inherent responsibility. Yet now, a rare opening has emerged, one that offers those in positions of legal authority the chance to act with genuine integrity. You have the opportunity to stand with the people and be remembered as a figure who helped restore alignment with natural law and true justice, or to continue enabling a system that places self-governing beings under constant duress, resulting in unconscionable suffering and misery, born from being corralled into the abandonment of personal responsibility and self-governance in every aspect of life.

We urge you to solemnly consider this opportunity, to act for the good of every individual in the community, and to fulfil your moral responsibility as legitimate public servants, by making your focus the immediate encouragement and return of the lawful Trial-by-Jury system as outlined in Magna Carta 1215, which is the single most powerful tool for the restoration of true lawful authority and true democracy, whereby the people control the law and govern themselves in peace.
